TERMS OF AGREEMENT

- Set up is Saturday, August 5th at 10 am Vendors not on time may not be placed.
- Be prepared to spend a few hours as we will be placing each vendor according to a pre-arranged schedule.

FOOD VENDOR'S OBLIGATIONS:

VOICES OF THE NATIONS, INC.

- 1) The Vendor agrees to set up, operate, and dismantle, its food operation in the location determined by Voices Of The Nations and assumes all costs for it. Truck is electrically powered. No generator or idling allowed within the square.
- 2) The Vendor agrees that no food items or non-alcoholic beverages shall be sold without the written consent of Voices Of The Nations.
- 3) The Vendor agrees to operate his/her food booth for the hours during the Music Festival. Vendors that do not follow this rule will be seen as having breached their contract and will be expelled from the grounds without refund.
- 4) The Vendor agrees to maintain the premises it occupies in a clean and orderly condition.
- 5) The Vendor must rigorously maintain all Board of Health standards and regulations. Breaches of any health regulations shall result in the immediate expulsion of The Vendor, and Voices Of The Nations will not be required to refund any monies to The Vendor. Toronto Public Health forms MUST be completed and returned to Voices Of The Nations with this application.
- 6) The Vendor will be responsible for obtaining and paying for all necessary permits, licenses, insurance and any inspections that may be required. The Vendor **MUST** have at least one person with a **Food Handler Certification** available at the booth.
- 7) The Vendor shall, upon signing this agreement, provide a full menu complete with prices of the requested foods and beverages to be sold, color picture of the unit (inside and out), statement of



outside dimensions (including tongue) and hydro requirements, proof of \$2,000,000 liability insurance protection, naming Voices Of The Nations Inc. This is mandatory every year.

- 8) The Vendor shall bear full responsibility for its truck(s) and trailers and shall park in areas designated by Voices Of The Nations.
- 9) Without restricting the generality of the foregoing, the Vendor shall comply with all City and Provincial regulations concerning all food concessions together with Voices Of The Nations regulations concerning food concessions. Vendors must produce current TSSA certificate along with application to prove compliance before being placed. Any vendor not in compliance will not be
- placed and will forfeit their concession fee. Re-inspection is required every year.

 10) In consideration of the right given to it by Voices Of The Nations to sell food items and non-alcoholic beverages and retain the profits of such sales for its own benefit. The Vendor agrees to pay Voices Of The Nations the above noted agreed upon Vending Amount to the Business Organizer (applicable to August 5th, 2023 ONLY) with this Application and all requested materials attached.

 An NSF cheque will forfeit your right to be a vendor in Voices Of The Nations Performing Arts Festival and subject to \$100.00 service charge.
 - 11) This Agreement shall not be assignable by The Vendor without the consent in writing of Voices Of The Nations. **Voices Of The Nations will review all vendor applications and decide which ones to accept.**
 - 12) The Vendor agrees to collect from patrons and remit to the government the Harmonized Sales tax (HST) when and where applicable.

VOICES OF THE NATIONS INC.'s OBLIGATIONS:

- 13) Voices Of The Nations shall provide to The Vendor, locations designated by Voices Of The Nations, such locations to be determined in the absolute discretion of Voices Of The Nations having regard to the conflict of concession and vendor types. The Vendor will receive the opportunity to display your food cart and/or table with banner.
- 14) Voices Of The Nations covenants to supply The Vendor with an electrical power source and water as required by the vendor.
- 15) Voices Of The Nations and The Vendor agree that The Vendor shall sell the ITEMS AND PRICES ON THE MERCHANDISE

LIST/MENU SUPPLIED, which have been approved by Voices Of The Nations.
